### **Purpose and legal basis of processing for necessary data**

Your personal data will be processed to fulfil obligations arising from your declaration of responsibility for minors. The processing will be based on the principles of correctness, lawfulness, transparency and protection of your privacy and rights.

### **Duration of data retention**

Your personal data will be retained also after the termination of the contract for the performance of all the obligations connected with or arising from said contract for the period of time prescribed by the prevailing laws in force and according to the limitation period of rights arising from the contract itself.

### **Nature of the provision of data and consequences of refusal**

Data provision is mandatory for legal and contractual obligations, as such any refusal to provide data, in whole or in part, may result in it being impossible for the Company to execute the contract or to properly perform all related obligations.

### **Methods of processing**

The processing will be carried out in an automated and/or manual manner, with methods and tools aimed at guaranteeing maximum security and confidentiality, by the authorised individuals.

### **Recipient categories**

All data collected and processed may be provided, exclusively for the previously indicated purposes, to internal figures authorised to process personal data in the performance of their respective duties, as well as to the following categories of external subjects:

- Business managers/Village caterers;
- Professionals or service companies acting on behalf of our company;
- Credit institutions;
- Insurance;
- credit recovery company, commercial information company, factoring company, consulting company;
- lawyers and legal advisors;
- Public and private bodies, also following inspections and verifications;

These recipients, in situations which they may be required to process personal data on behalf of our Company, will be designated as data controllers, under the terms of a specific contract or other legal document.

### **Transfer the data to other countries and/or to international organisations**

Your personal data will be transferred to third countries within the union.

### **Data Subjects' Rights**
